

**AN ORDINANCE TO AMEND ARTICLE IV OF CHAPTER 82 OF THE  
CODE OF THE TOWN OF LURAY, VIRGINIA**

**WHEREAS**, the Town of Luray, Virginia (the “Town”) has parking lots within Town limits which are open to the public and designed to accommodate fifty or more vehicles; and

**WHEREAS**, § 46.2-1219 of the Code of Virginia authorizes the Town to regulate the flow of vehicular and pedestrian traffic, the parking of vehicles, and speed limits in such parking lots; and

**WHEREAS**, Town Council finds that authorizing the Town Police Department to enforce the regulations set forth in Chapter 82, Article IV, Division 1 of the Town Code within such parking lots would promote the safety of Town residents as well as nonresidents who support Town businesses; and

**WHEREAS**, Chapter 82, Article IV, Division 2 of the Town Code authorizes and requires the Town Manager to establish parking meter zones within the Town; and

**WHEREAS**, there are no longer any parking meter zones within the Town and Town Council does not wish that any new parking meter zones be established.

**NOW, THEREFORE**, be it ordained by the Council of the Town of Luray, Virginia, as follows:

1. Chapter 82, Article IV, Division 1, Section 82-141 of the Code of the Town of Luray, Virginia, shall be amended under the authority of Virginia § 46.2-1219 as follows:

**Sec. 82-141.- Regulation of vehicular and pedestrian traffic on certain parking lots.**

The regulations set forth within this Division shall apply to all parking lots within town limits which are open to the public and designed to accommodate fifty or more vehicles. The town police department is authorized to enforce all such regulations and prohibitions within such parking lots.

2. Chapter 82, Article IV, Division 2 of the Code of the Town of Luray, Virginia, is hereby repealed in its entirety.

3. This Ordinance will take effect immediately.
