Luray, VA – Code of Ordinances

Chapter 66 – Second Hand Goods

Article I. – In General

Sections 66-1 – 66-30 – Reserved

Article II. – Yard Sales; Garage Sales

Section 66-31. – Activities subject to this article.

All yard sales, lawn sales, porch sales, attic sales, garage sales, room sales, backyard sales, patio sales, flea market sales, rummage sales and sales from within dwellings and other structures not being retail or wholesale stores are subject to the provisions hereof.

Section 66-32. – License – Required

It shall be unlawful for any person or organization to conduct any such sale, work at any such sale, advertise any such sale, or display property which would reasonably appear to be for any such sale, or anyone owning property or leasing the same who permits any of the foregoing to take place on such property, to do so without first securing a license therefor. Only one license shall be required for any such sale, and it may be issued in the name of the property owner or lessee, or in the name of the person responsible for conducting the sale.

Section 66-33. – Same – Application, required information fee, duration, frequency of sale.

(a) Such license shall be issued by the Department of Police, Town of Luray, Virginia or by the Clerk's Office, Town of Luray, Virginia. Prior to the issuance of the license for any such sale, the individual(s) conducting such sale shall file a written, signed application with the Department of Police, Town of Luray, Virginia or by the Clerk's Office, Town of Luray, Virginia, setting forth the following information:

- (1) Full name, address and phone number of the applicant, and if the applicant is the owner, leaser or renter of the location of the proposed sale.
- (2) The physical address, location at which the proposed sale is to be held.
- (3) The date, or dates, upon which the sale shall be held.
- (4) The date, or dates, of any other such sales within the current calendar year at the location of the proposed sale.

(b) There shall be no fee imposed for the license. However, no physical address, location or property shall be permitted more than two such sales in a calendar year. No sale shall last longer than three consecutive days.

Sec. 66-34. – Daily hours.

Any sale conducted pursuant to the provisions hereof shall be limited in time to the hours of 8:00 a.m. to 5:00 p.m.

Sec. 66-35. – Posting of signs.

All signs shall conform to the requirements of article VIII of appendix A of the Town Code.

Sec. 66-36. – Impeding vehicular or pedestrian traffic prohibited.

No personal property sold or offered for sale shall be placed, kept or displayed on or in any public right-of-way or in any manner so as to interfere with or impede the flow of vehicular or pedestrian traffic.

Sec. 66-37. – Exemptions.

Periodic sales held exclusively at churches or other places of worship, public or private schools, or other similar places of public assembly under the auspices of a nonprofit organization operated exclusively for religious, charitable, community or educational purposes are exempt of the requirements of the article.

Sec. 66-38. – Penalty for violation.

Any person or persons or organization violating the provisions hereof shall be subject to the penalties set forth in section 30-34.
